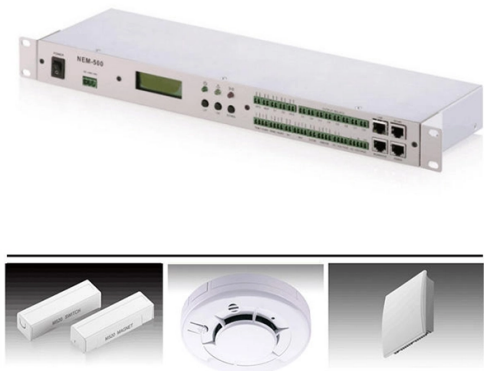

Overview

Submit an Import Declaration through the Japan Customs' electronic system (NACCS – Nippon Automated Cargo and Port Consolidated System). Key documents required include a commercial invoice, packing list, and bill of lading. Import duties depend on the goods and are calculated. When you enter Japan, you are requested to hand in a Customs Declaration form for both your personal effects and unaccompanied baggage at the Customs Clearance. Having a local representative in Japan and/or working with a. You will receive ORIGINAL C5360-2 form on the plane before arriving to Japan. You will fill out both forms, and then you will submit them to Japanese Customs after picking up your suitcase in the airport. HS code is a code adopted for the purpose of unifying names and classes of goods traded internationally.
